Overview

The agreement covers automated decontamination/disinfection systems for use with semi critical ultrasound probes and semi invasive/non-invasive ultrasound probes. High level disinfection is required to kill the Human papillomavirus (HPV virus). The aim of this procurement is to support and work with trusts to comply with best practice guidance on the decontamination/disinfection of Ultrasound Probes from Health Protection Scotland, Health Facilities Scotland, Welsh Technical Memorandum WHTM01-06 and Irish Health executive. Guidance is currently being developed for England to support this.
